# **Gozo General Hospital**

#### Structure, Functions and Responsibilities

Gozo General Hospital is the only hospital on the island of Gozo, providing acute and complex services, emergency services, inpatient and outpatient services and community outreach services. The hospital plays a critical role in minimizing impacts in emergencies through preparedness, response, safety, and security. It also provides standby capacity to accommodate any type of public health crisis like a disease outbreak or incident with mass casualties. In addition, Gozo General Hospital provide facilities and related services for psychiatric and long-term care. The Hospital is in a strategic alliance with Barts and The London School of Medicine and Dentistry (Malta) and offer the necessary clinical and support facilities for medical students during their clinical placements.

Our vision is to build and evolve a sustainable and integrated healthcare system which delivers comprehensive, high quality, and patient centred health services to the community which we serve.

Gozo General Hospital has a total of 322 beds, of which 121 are in acute care settings, 161 beds in long-term care and 40 beds in ambulatory care. The hospital employs a total of 1023 employees, comprising clinical and non-clinical staff together with other support staff. Visiting consultants from other hospitals visit Gozo General Hospital and hold various specialised clinics mostly on outpatient basis. The hospital caters for the following main clinical services: Emergency Medicine and Pre-hospital care, Medicine, Surgery, Anaesthesia and Intensive Care, Orthopaedics, Obstetrics and Gynaecology, Paediatrics, Dentistry, Long-term Care, Psychiatry, Social Care, Renal Dialysis, Allied Health Services, Outreach Services (including Post Natal, Urology and Orthopaedic home visits), and Chemotherapy Infusion administration.

Gozo General Hospital is connected with Mater Dei Hospital on the mainland by means of 24/7 air and land ambulance/s services for emergency and specialized care.

## **General Description of the Categories of Documents Held**

Our hospital documents are legal documents as they contain the information necessary for the correct and optimal care of patients and clients. Clinical documents relate to patient's information capturing all the clinical activity. Non-clinical documents include those documents which are of an administrative or social nature that allow for good management, coordination, and organisation of the resources, as well as correct functioning of different departments.

Information may originate from individuals or organizations, public or private; these may be Maltese or foreign, and be located in Malta, in other EU Member States, or far off places/countries.

Documents and information may originate from, or have been addressed to, the various clinical, scientific, engineering, and administrative functions and roles within Gozo General Hospital, as per the organizational chart, and the roles and functions shown.

Such information / documents held by Gozo General Hospital may be about wellness, lifestyles, disease, employment and/or business activities, treatment, and medication, and may appear in the following:

- Forms
- Records
- Files
- Manuals
- Studies
- Plans
- Correspondence
- Circulars
- Specifications
- Reports

Depending on the operational requirement of the hospital. Such information/documents may relate to:

- Imaging and laboratory tests

The guiding principle in collecting, using, and sharing such documents and information shall be our healthcare giving mission, the rights of patients, and observance of the Law, including the Freedom of Information Act, legislation providing for professional secrecy and the Data Protection Act.
